



Authorized Trade Reporter Registration

Registration of Block Trade/ECRP Reporters

A Responsible Trader of each Clearing Member must notify CBOE Futures Exchange, LLC ("CFE") of all individuals authorized to report Block Trade and Exchange of Contract for Related Position ("ECRP") transactions on behalf of the Clearing Member ("Authorized Reporters"). Authorized Reporters must be registered with CFE and receive official clearance to proceed before Block Trades/ECRPs are executed and reported on CFE.

To Register Authorized Reporters:

1. A Responsible Trader completes and signs the attached Block Trade/ECFP Authorized Reporter Registration Form and submits it to CFE via fax at (312-786-7050) or mail (CFE, 400 South LaSalle Street, 4th Floor, Help Desk, Chicago, IL 60605).
2. CFE contacts the Responsible Trader to discuss the Form and the applicable reporting requirements.
3. The CFE Help Desk sets up IDs for each of the Authorized Reporters.
4. The CFE Help Desk contacts each Authorized Reporter to verify his/her Reporter ID number and other submitted information.
5. The CFE Help Desk faxes the final form back to the Responsible Trader, including any changes/updates.
6. The Responsible Trader initials the finalized document to approve any changes and faxes it to CFE at (312-786-7050).
7. The CFE Help Desk calls each Authorized Reporter a second time and provides official clearance to proceed with Block Trades/ECRPs.
